Esso Exploration & Production Guyana Ltd (EEPGL) will continue with their scheduled 3D/4D seismic survey within the Southeastern Portion of the **Stabroek Block** of the Guyana Maritime Zone.

Total duration of the survey is extended until December 31, 2019.
