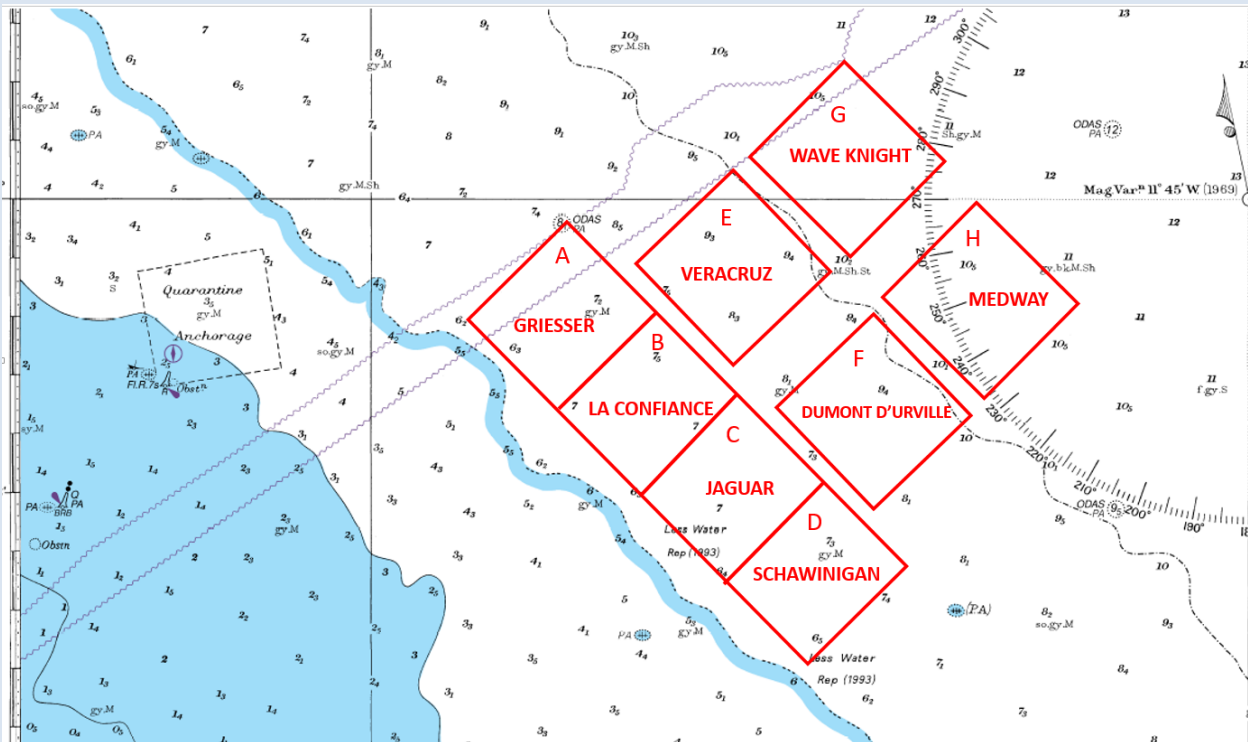
This exercise is scheduled to conclude on June 26, 2021, and will incorporate the below listed military vessels:
