OFFSHORE GUYANA

Koole BV contracted by the Maritime Administration Department, will continue with the removal of wrecks and obstructions that are located in Guyana's waterways.

This operation is scheduled to conclude on **December 31, 2023**, and will incorporate the use of *AHT Koole 42 and MB H283* which would display the international signal for vessels engaged in such activities.
