**NOTICE TO MARINERS**

**OFFSHORE GUYANA**

*U-Mobile (Celluar) Inc* will commence Subsea Fibre Optic Cable Installation activities within Guyana's Exclusive Economic Zone.

This exercise is schedule to conclude on **December 31, 2023** and will incorporate the use of the *MPV TSM Quessant* which will display the international signal for vessels engaged in such activities.

The cable laying area is situated approximately 5.1 nautical miles (9.5 kilometers) off the Coast of Guyana and covers an area of 3.0 square nautical miles (10.3 square kilometers); bounded by the following coordinates:

All mariners are required to stay clear of this vessel and navigate with extreme caution when in the vicinity.

Vessels are therefore prohibited from anchoring in close proximity to these cables. Anchoring would only be permitted at a minimum distance of **250 meters** from the cable position when the vessel rides on her anchor.
