ExxonMobil Guyana Limited (EMGL) will continue Deep Water Development operations within the Yellowtail, Whiptail, Liza, Payara and Uaru 1 & 2 fields within **Stabroek Block** of Guyana’s Exclusive Economic Zone.

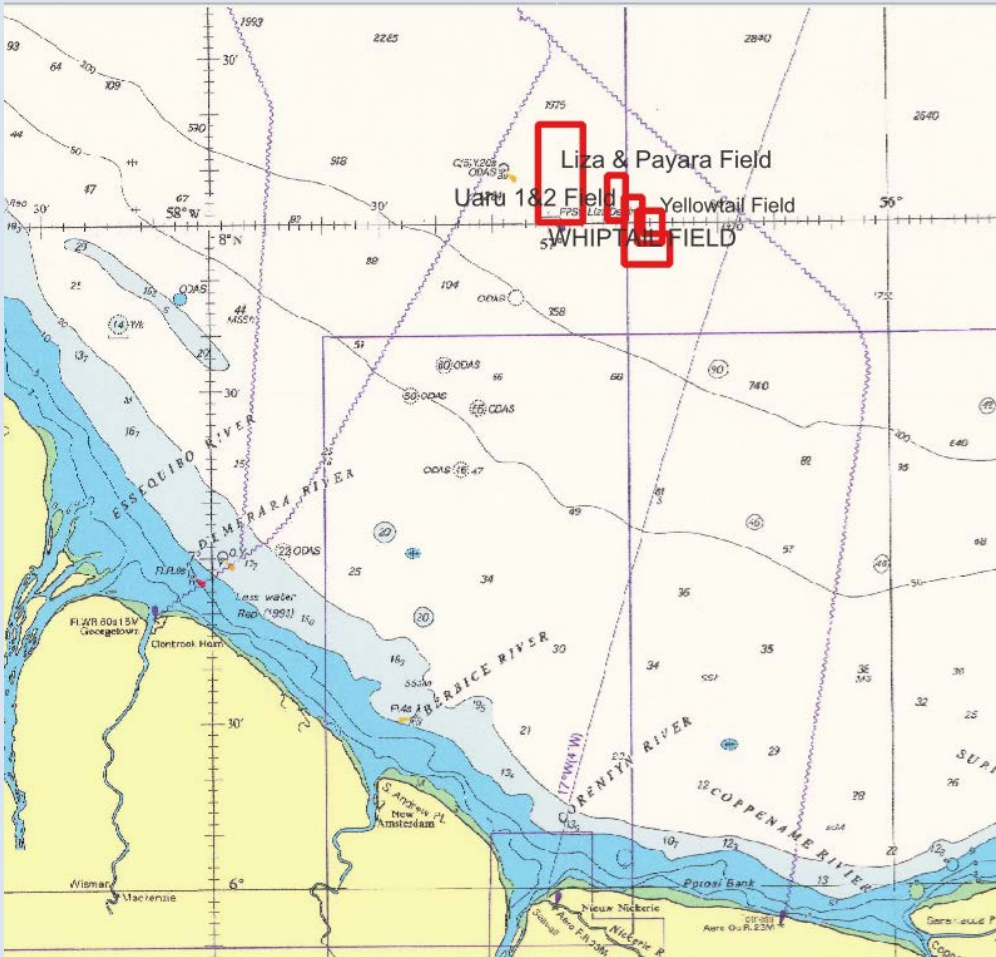
The areas are situated approximately 107.4, 97.1, 105.6 and 103.8 nautical miles (198.9, 179.8, 195.7 and 192.3 kilometers) off the Coast of Guyana, and covers an area of 25.4, 136.8, 25.8 and 64.8 square nautical miles (87.4, 469.3, 88.6 and 222.3 square kilometer); bounded by the following coordinates:
